

DECALOGUE OF COLLABORATION

(For supporters interested in collaborating with the Usher Syndrome Foundation in Spain*)

The **USHER SYNDROME FOUNDATION** in achieving its founding purpose, and as an entity that deploys the **SAVE SIGHT NOW** global initiative in Europe with the organization **SAVE SIGHT NOW EUROPE**, wants to promote all kinds of actions to 'facilitate the collection of funds with the ultimate aim of assisting in scientific research and the search for a treatment for Usher's Syndrome in its 1B variant.

The Foundation is open to participating, promoting, and encouraging the initiative of third parties or interested persons - henceforth Supporters - who wish to carry out actions with the same objective and who make the results available to the Foundation, as the best vehicle to give vent to the altruism generated.

In this sense, it is in the interest of the Usher Syndrome Foundation and the Save Sight Now Europe initiative to establish a framework of transparency and traceability around any activity that involves one or more third parties making financial contributions, however simple, aimed at the objectives that persecute; and this is relevant whether contributions are made through actions carried out directly by the Foundation or through Supporters who then revert the results to the Foundation. Only in this way will the goal we all pursue be reliable and generate a new willingness to contribute resources aimed at the common goal.

For all this, the performance of acts or actions in the interest and benefit of the Usher Syndrome Foundation -from now on FSU- and the initiative Save Sight Now Europe -from now on SSNEU- (or in other words, the organization of initiatives or events aimed at collecting funds intended for FSU and SSNEU) must be carried out in compliance with the conditions and requirements that are listed below:

- 1. Any action aimed at raising funds for the FSU and the SSNEU initiative must be communicated to the FSU, indicating the details that are required by it through a form that will be available on its website. Together with the form, the Supporters who intend to organize the action must provide a signed commitment sheet with this decalogue which is included at the end as an annex.
- 2. If the FSU accepts the performance of the action: will communicate this to Supporters as soon as possible and in writing will provide them with the digital files with the logo and graphic image of both FSU and SSNEU -with instructions on how to use them-, and will publish the event or action on its website identifying its promoters.

- 3. Without the acceptance and confirmation of the action on the FSU website indicated in the previous section, the authorization to use the name and logos of the FSU or SSNEU cannot be considered granted, nor recognized proposed action. The use of names and logos is understood to be authorized only for the specific action recognized.
- 4. The FSU will always value the provision of material considering the type of event and scope-. This will be provided whenever there is availability, without this implying any additional obligation than that of providing files of logos and graphic images in digital format. In addition, any dissemination text generated, external to the Foundation and the organization, using its image, must follow the Foundation's general communication guidelines and be approved by it.
- 5. Every Supporter undertakes to, once the action has ended, disclose the final total amount collected, through the channels used to publicize the action. The final total amount of the collection will be the subject of a contribution to the FSU via bank transfer to the Foundation's account on the website of Save Sight Now Europe Fundació Síndrome d'Usher.
- 6. The FSU undertakes to disseminate on its communication channels the recognized and accepted actions. In the same way, the FSU will publish on its website the amount or amounts received from each of the initiatives collected there.
- 7. For fiscal purposes and by the applicable regulations, the FSU can only deliver, if so requested, a certificate to the person or entity from which it receives the direct contribution at the end and closure of each action.
- 8. If a Supporter who organizes an action comes into contact with a large donor who conditions his contribution on obtaining the tax benefits of patronage actions regulated by the applicable legislation, the collaborator in question I 'will directly address the FSU providing their contact details.
- 9. The participation of the FSU by advising a Supporter in the realization of an action to collect funds does not imply any kind of responsibility of the FSU. The Supporters are solely responsible to third parties for the contents, whether images, videos, audio, or texts that are published or disseminated during the execution of the action, and in any case release the FSU from any responsibility for the claims of third parties about an unauthorized use of these contents and materials.
- 10. The breach by a Supporter of any of these rules, verified by the FSU, entitles the latter to remove him from the list of Supporters published on the website, as well as to make public communications that it deems relevant concerning this situation.
