



COLLABORATION CHARTER

Save Sight Now Europe (SSNEU)

Usher Syndrome Foundation – Spain / Save Sight Now Europe Association – Switzerland

Introduction

This charter is intended for individuals or entities who wish to support Save Sight Now Europe (SSNEU), an organization active in Spain and Switzerland. Its core mission is to promote fundraising initiatives to support scientific research and the development of treatments for Usher syndrome, especially type 1B.

The organization warmly welcomes the participation, promotion, and support of third parties or individuals — hereinafter referred to as “Collaborators” — who aim to carry out initiatives aligned with these objectives and to channel the outcomes to SSNEU as a meaningful expression of their solidarity.

In this context, it is in SSNEU’s interest to establish a framework of transparency and traceability for any activity involving financial contributions, however simple, in support of these goals. This applies both to contributions made directly to the organization and those collected by collaborators and subsequently transferred to SSNEU. This is the best way to ensure trust in our shared goals and to encourage continued commitment to supporting our cause.

For this reason, any initiative intended to benefit SAVE SIGHT NOW EUROPE (including the Usher Syndrome Foundation — hereinafter FSU — and the Save Sight Now Europe Switzerland Association — hereinafter SSNEUCH) and the SSNEU initiative must comply with the following **conditions and commitments**:

Conditions and Commitments

1. Prior communication of initiatives:

Any fundraising action to support SSNEU must be communicated in advance using the official form available on the organization’s website. Collaborators must also sign this charter to formalize their commitment.

2. Formal approval:

Once an initiative is approved, SSNEU will:

- Send written confirmation.
- Provide the official logos and graphic materials along with usage guidelines.
- Share the event or action on its official channels, identifying the organizers.

3. Use of logos and name of the organization:

Permission to use SSNEU's logos and name is strictly limited to the approved action. Any unapproved use is considered unauthorized.

4. Material support:

Depending on availability, SSNEU may provide additional materials for the event. All external communication using the organization's image must comply with its communication guidelines and receive prior validation.

5. Financial transparency:

Collaborators are required to publicly share the financial outcome of their initiative through the same communication channels used to promote it. Funds collected must be transferred via bank transfer to the official account indicated on SSNEU's website.

6. Disclosure of contributions:

SSNEU will publicly share the amounts received and the approved actions via its official communication channels.

7. Tax certificates:

Accordingly with Swiss and Spanish regulations, SSNEU can only issue tax certificates for donations made directly to the organization.

8. Major donations and tax benefits:

If a donation is conditional on receiving tax benefits, the collaborator must share the donor's contact information with SSNEU so that the organization can follow up directly.

9. Responsibility of collaborators:

Collaborators are solely responsible for the content (images, videos, text, audio) used or shared during their initiatives. SSNEU disclaims any liability in the event of third-party claims related to unauthorized use.

10. Violation of the rules:

In case of non-compliance, SSNEU reserves the right to remove the collaborator from its official list and publish relevant public communications.
